Ewa Błaszczak

is Molecular Biologist, currently a University Professor at the Department of Biochemistry and Molecular Biology at the Medical University of Lublin, Poland. From 2016 to 2022, she was a researcher and lecturer at the Faculty of Biological Sciences at the University of Wrocław, Poland. She completed her doctoral thesis at the Institute of Genetics and Development of Rennes (IGDR), France, and obtained a Ph.D. in Biology from the University of Rennes 1 in 2015. Earlier, she graduated from the University of Westminster in London, UK (M.Sc. in Medical Molecular Biology) and the University of Life Sciences in Lublin, Poland (M.Sc. in Biology). Her research interests focus on molecular mechanisms of cancer development, progression and invasion. She is particularly interested in proteins, their interactions and post-translational modifications that influence various cellular processes. Since 2017, she has been a member of the Academy of Young Scholars and Artists, and in the years 2019–2021 she was a member of the Presidium of the Academy. Additionally, she is a philologist and an English translator with a Diploma in Translation Studies obtained from the University of Portsmouth, UK. She participated in the 68th Lindau Nobel Laureate Meeting that took place in Germany. She also popularizes science through workshops and lectures.

Małgorzata Cebrot

is currently Head of the Laboratory of Molecular and Cellular Immunology at the Ludwik Hirszfeld Institute of Immunology and Experimental Therapy, the Polish Academy of Sciences, Wrocław. She is a molecular immunologist, researcher, lecturer, and beekeeper. Her research interests focus on the control of gene expression during the maturation of the immune system and the evolution of the adaptive immune system. Her scientific work centres, moreover, on topics related to the gender of bees, particularly as seen from the perspective of molecular biology and genetics. This includes recently identifying gene variants of *CSD* that determine the sex of bees. She graduated from the Faculty of Biotechnology at the University of Wrocław and did her Ph.D. in Biology at the Institute of Immunology and Experimental Therapy. In the years 2010–2013, she was the Chairwoman of the Academy of Young Scholars and Artists. She is the author of numerous peer-reviewed publications, and works to popularize science among young people.

Jakub Jernajczyk

is Visual Artist, popularizer of science, Ph.D. in the Arts, MA in Mathematics. He graduated from the Faculty of Mathematics and Computer Science of the University of Wrocław and the Faculty of Graphic Arts and Media Art at the Eugeniusz Geppert Academy of Art and Design in Wrocław. Currently Dean of the Doctoral School and Professor at the Media Art Department at the Academy of Art and Design in Wrocław. He has participated in many scientific conferences and many artistic exhibitions in Poland and abroad (including, but not limited to, Germany, South Korea, Australia, the United States, China, New Zealand, Romania, Hungary, Great Britain, the Czech Republic and Slovakia). In his creative, scientific and didactic work he mainly focuses on the relationship between the arts and science. He creates installations, most frequently of a multimedia-based and interactive kind, in which he deals creatively with scientific issues.

Bartłomiej Skowron

He seeks to further the flourishing of philosophy by both practising it and promoting it through research and educational initiatives, such as *Proper Thinking* (critical thinking workshops for high-school students) and *Filomates* (a project exploring the non-obvious connections between mathematics and philosophy). He has authored over 45 original articles, as well as a book entitled *Part and Whole: Towards Topo-Ontology*. Beyond this, he is an enthusiast of long-distance running and a fan of newly emerging technologies.

Weronika Urbańska

is Doctor of Engineering and Technology in the discipline of Environmental Engineering, Mining and Energy, specializing in Waste Technology; Assistant Professor (undertaking research and teaching) at the Faculty of Environmental
