



Instructions for Authors

Scope

The *Journal of Ancient Judaism (JAJ)* addresses all issues of Jewish literature, culture, religion, and history from the Babylonian exile until the Babylonian Talmud. As a cross disciplinary journal it is of interest for all those concerned with Biblical, Jewish, religious, cultural and historical studies. The journal welcomes submissions in any of these subject areas and disciplinary methods. Articles that reflect the journal's interdisciplinary character by working across multiple fields or disciplines or introducing new and innovative disciplinary approaches to the study of ancient Judaism are especially encouraged. The journal appears three times per year (in April, August, and December) and includes one annual theme issue (usually prepared by guest editors). To propose a topic for a theme issue, please contact the editors.

Ethical and Legal Conditions

The publication of a manuscript in a peer-reviewed work is expected to follow standards of ethical behavior for all parties involved in the act of publishing: authors, editors, and reviewers. Authors, editors, and reviewers should thoroughly acquaint themselves with Brill's publication ethics, which may be downloaded here: brill.com/page/ethics/publication-ethics-cope-compliance.

Online Submission

JAJ uses online submission only. Authors should submit their manuscript online via the Editorial Manager (EM) online submission system at: editorialmanager.com/jaj. First-time users of EM need to register first. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested. During registration, you can fill in your username and password. If you should forget your Username and Password, click on the "Send Username/Password" link in the login section, and enter your first name, last name and email address exactly as you had entered it when you registered. Your access codes will then be e-mailed to you.

Prior to submission, authors are encouraged to read the 'Instructions for Authors'. When submitting via the website, you will be guided stepwise through the creation and uploading of the various files.

A revised document is uploaded the same way as the initial submission. The system automatically generates an electronic (PDF) proof, which is then used for reviewing purposes. All correspondence, including the editor's request for revision and final decision, is sent by e-mail.

Double-blinded Peer Review

JAJ uses a double-blind peer review system, which means that manuscript author(s) do not know who the reviewers are, and that reviewers do not know the names of the author(s). When you submit your article via Editorial Manager, you will be asked to submit a separate title page that includes the full

title of the manuscript, the names and complete contact details of all authors, the abstract, keywords, and any acknowledgement texts. This page will not be accessible to the referees. All other files (manuscript, figures, tables, etc.) should not contain any information concerning author names, institutions, etc. Citations to the authors' own work should be in the third person. For the same reason, authors are advised to hold off on including acknowledgments until they finalize the manuscript for publication. The names of these files and the document properties should also be anonymized. Tables, illustrations and other figures should also be uploaded as separate files. Please note that the typesetting area of the journal is 11.5 x 18 cm, and ensure that all tables and illustrations fit this size. Also ensure that the dpi for any illustration is at least 300.

File Format

Please upload manuscripts in both the form of a source file (such as .doc, .rtf, or .mellel), as well as a pdf.

Submission Requirements

Language

JAJ accepts submissions in English, German, and French. American English is preferred, but in any case spelling should be consistent throughout any submission.

Fonts and Non-Roman Scripts

Authors should avoid excessive inclusion of textual passages in original languages. Hebrew text (for example in quotations from the Hebrew Bible) should only be vocalized where the vowels are relevant for the discussion in the article.

Length

JAJ publishes articles of up to 20,000 words, although in unique circumstances somewhat longer articles may be accepted.

Manuscript Structure

Article submissions should follow the *SBL Handbook of Style*, 2nd edition.

For cases of style that are not covered by the *SBLHS*, authors should consult the *Chicago Manual of Style* chicagomanualofstyle.org/home.html.

Abstract and Keywords

Full length articles should contain a short abstract of 100–150 words in English and a list of 4 to 7 keywords. The abstract and keywords should always be written in English, regardless of the language in which the article is written.

Headings

Authors may use as up to three levels of numbered headings. All are presented flush left.

First-level headings (1) are formatted in **bold** and appear with two blank lines above and one below.

Second-level headings (1.1) are formatted in ***bold italics*** and appear with one blank line above and none below.

Third-level headings (1.1.1) are formatted in Roman and appear with one blank line above and none below.

Bibliography

JAJ uses both short footnotes and a bibliography (reference list including all works cited in the notes) at the end of the manuscript.

The bibliography should be formatted according to the *SBL Handbook of Style*, 2nd edition.

References to online publications, including pre-published journal articles, should include the DOI (digital object identifier); see the *SBL Handbook* 6.1.6.

References to bibliographical items written in Hebrew should use the non-Hebrew language title that appears in the book or journal, indicating the original language in parentheses. If such a non-Hebrew language title is not provided, transliterate the title.

Citation in the Footnotes

In the footnotes, use shortened citations, even at first mention. The short form should include enough information to remind readers of the full title or to lead them to the appropriate entry in the bibliography. The short form generally consists of the last name of the author and the main title of the work cited, usually shortened if more than four words, with, where appropriate, reference to specific page numbers. For the form of short citations see the examples in *SBL Handbook*, 6.2-3, or the guidelines in *The Chicago Manual of Style*, 16th edition, 14.24-28.

Bibliography

The journal uses footnotes and a bibliography (reference list including all works cited in the notes) at the end of the manuscript. References to bibliographical items written in Hebrew should use the non-Hebrew language title that appears in the book or journal, indicating the original language in parentheses. If such a non-Hebrew language title is not provided, transliterate the title.

If there are multiple works by the same author, give the oldest one first.

Repeat the surnames, do not use a dash.

Pagination

Please give the abbreviated form of pagination when given in both notes and bibliography: 25-28, 71-163, but 549-50, 162-63.

Figures

Figures refer to graphs, charts, drawings and pictures. All figures must be cited in the text. If there are figures in the manuscript, the author must upload figure files as separate files. These figure files must be uploaded as source files (.jpeg, or .tif), and not .pdfs. If there are figures in color, there must also be a black and white file for each figure. The size of the figure must be appropriate for the journal, which is 11.5 x 18 cm.

The quality of the figure must be suitable for printing—the resolution should be a minimum of 300 dpi (minimum 600 dpi for line art). The image itself must be sharp, and any text in the figure should be legible (at least corps 7 or larger).

It is the author's responsibility to deal with any eventual permissions concerning the reproduction of any figures; please see point 6 of the Ethical and Legal Conditions above. Please also provide a separate list of figure captions.

Tables

Tables do not have hairlines when printed, so keep any formatting to a minimum, and the size to 11.5 x 18 cm.

Publication

Proofs

Upon acceptance, a PDF of the article proofs will be sent to authors by e-mail to check carefully for factual and typographic errors. Authors are responsible for checking these proofs and are strongly urged to make use of the Comment & Markup toolbar to note their corrections directly on the proofs. At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication, and therefore, those in excess of 10% of the original composition cost will be charged to authors. Proofs should be returned within one week of receipt.

E-offprints

A PDF file of the article will be supplied free of charge by the publisher to authors for personal use. Brill is a RoMEO yellow publisher. The Author retains the right to self-archive the submitted (pre-peer-review) version of the article at any time. The submitted version of an article is the author's version that has not been peer-reviewed, nor had any value added to it by Brill (such as formatting or copy editing). The Author retains the right to self-archive the accepted (peer-reviewed) version without any embargo period. The accepted version means the version which has been accepted for publication and contains all revisions made after peer reviewing and copy editing, but has not yet been typeset in the publisher's lay-out. The publisher's lay-out must not be used in any repository or on any website (brill.com/resources/authors/publishing-books-brill/self-archiving-rights).

Consent to Publish

Transfer of Copyright

By submitting a manuscript, the author agrees that the copyright for the article is transferred to the publisher if and when the article is accepted for publication. For that purpose the author needs to sign the **Consent to Publish** which will be sent with the first proofs of the manuscript.

Open Access

Should the author wish to publish the article in Open Access he/she can choose the Brill Open option. This allows for non-exclusive Open Access publication under a Creative Commons license in exchange for an Article Publication Charge (APC), upon signing a special Brill Open Consent to Publish Form.
