



Scope

RSSSR is an interdisciplinary and international annual series which disseminates original reports of research related to the sociology and/or psychology of religion. Manuscripts should be original contributions (not reprints or material available on the internet) based upon appropriate quantitative or qualitative methods of research applied to the study of religion. They should not be under consideration for publication elsewhere and should comply with the professional ethical standards of psychology, sociology, and other social science professions.

Ethical and Legal Conditions

Submission of an article for publication in any of Brills' annuals implies the following:

1. All authors are in agreement about the content of the manuscript and its submission to the journal.
2. The contents of the manuscript have been tacitly or explicitly approved by the responsible authorities where the research was carried out.
3. The manuscript has not been published previously, in part or in whole, in English or any other language, except as an abstract, part of a published lecture, or academic thesis.
4. The manuscript has not and will not be submitted to any other journal while still under consideration for this journal.
5. If accepted, the author agrees to transfer copyright to BRILL and the manuscript will not be published elsewhere in any form, in English or any other language, without prior written consent of the publisher.
6. If the submission includes figures, tables, or large sections of text that have been published previously, the author has obtained written permission from the original copyright owner(s) to reproduce these items in the current manuscript in both the online and print publications of the journal. Double-blinded Peer Review

The Journal annual uses a double-blind peer review system, which means that manuscript author(s) do not know who the reviewers are, and that reviewers do not know the names of the author(s). When you submit your article, you will be asked to submit a separate title page which includes the full title of the manuscript, plus the names and complete contact details of all authors. This page will not be accessible to the referees. All other files (manuscript, figures, tables, etc.) should not contain any information concerning author names, institutions, etc. The name of these files should also be anonymized.

General

Questions about suitability can be directed to the editors. Manuscripts that are judged by the editors as relevant to the coverage of RSSSR reviewed anonymously for quality and then either accepted (usually along with constructive suggestions for revision) or rejected. Manuscripts relevant to our subject that are not accepted for publication also receive the benefit of critiques and suggestions that can aid their



improvement for submission elsewhere. Authors will be required to complete a copyright transfer form giving Brill the rights to publish the work.

RSSSR is also interested in developing “special topic sections” for inclusion in future editions. Special topic sections include a series of guest-edited papers (usually 5–7) on a specific theme. If you have a suggestion for a special topic section or would be interested in editing such a section, please do not hesitate to contact the series editors.

Submission Requirements

Manuscripts may be submitted at any time during the year, although those received before the end of July have the best chance of inclusion in the volume of the following calendar year. Manuscripts are normally 5-7k words, including references and footnotes. Longer articles may be accepted, but justification for the extended length would need to be included in a covering letter. They should be submitted electronically in MS Word format to the editors.

Submit a title page containing the following information:

Title

Author(s) and affiliation(s)

Postal address

Date

Word count

Author note that may include:

Acknowledgements

Location of data used in the study that may be available

Person to contact with their email and telephone number

All sources should be identified in the text using the author-date system. References should be listed alphabetically with multiple references from the same author(s) listed chronologically, starting with the earliest. Formatting should conform to the following examples, using doi numbers where these are available.



Please conform to the following guidelines while completing and formatting your chapter.

1. Use Times New Roman font, size 12
2. Ensure text is double-spaced throughout
3. Typical article word length 5000 to 7000 words + references. Longer articles are possible with editor's approval
4. Headings
 - Title
 - Heading Level 1
 - *Heading Level 2*
 - *Heading Level 3*
5. Abstract
 - Please provide an abstract
 - Maximum word length for abstract is 300 words
 - Provide 6 key words at bottom of abstract
 - Italicize and indent abstract
6. Paragraphs
 - Please indent new paragraphs
 - No indent after a heading
 - No line space between paragraphs
7. Insert page numbers on lower right hand corner
8. Only highly relevant illustrations that are referred directly to in the text may be included. Please submit any illustration in .jpg or .tif format (NOT pasted into your manuscript itself) as high quality illustrations with a minimum of:
 - Regular photos/images: **.tif or .jpg** 1330 x 2000 pixels at 300 dpi for full page
 - Line drawings: **.ai or .eps** 2640 x 4000 pixels at 600 dpi for full page
9. Table and figures must be clearly labeled. Indicate in article where a table or figure belongs by adding **[INSERT FIG 1.1 HERE]** in the running text.
10. Please note that as the author, it is your responsibility to obtain all necessary permissions for the publication of any images, and pay any related fees, before the production process can be started.
11. On a separate page, provide major subject terms (up to twenty) to be included in an Index
