Each collection gives access to all online available content back to the year 2000. If an institution decides not to renew their subscription to the Collection, perpetual access to Collections is maintained for all years paid for.

The *Brill Journal Archives Online* (2017) offer access to over 5,500 volumes of 230 scholarly journals. The Journal Archives consist of two parts, the first covering the 19th and 20th century and the second covering part of the 21st century.
