## Brill Research Perspectives

Brill is pleased to introduce a new series of publications, *Brill Research Perspectives*: a hybrid journal-reference publication that combines the verification of peer review, the high usage of reference works, and the pedagogy of textbooks.

Designed for research communities in the Humanities and Social Sciences, these publications will distill the vast body of literature in a field into a more digestible format while linking to the primary sources. Taken together, the numerous series of *Brill Research Perspectives* will constitute a multidisciplinary digital



reference library that is linked to the original research.

### Key Features:

- Peer-reviewed, survey/review monographs of 50-100 pages.
- Snapshot of the state of scholarship in a given subject area with author's commentary and analysis.

- Complete bibliography linked internally to first-instance citation and externally to primary sources.
- Part of a discipline-wide digital reference library.
- Published in real time (online within 30 days of acceptance).
- Issues updated periodically by authors to revitalize commentary and analysis and to ensure currency of citations.
- Both subscriptions and individual e-book or print paperback copies of issues available.
