- **Our journals**, e-books and e-book collections are available on: booksandjournals.brillonline.com.
- **Over 240 journals** are now available **online** from Brill, **11** of which are **full Open Access** titles.

- Brill is committed to reflect a journal's **Open Access income** in the development of its subscription price. This price adjustment is determined by the change in the share of paid OA content. Following the year that this share exceeds 10%, measured from the last such price adjustment, this change in pricing will be applied. New journals will be excluded from this policy in the first five years of publication.
