William Burnham is a Professor of Law at Wayne State University Law School where he teaches Civil Procedure, Trial Advocacy, Federal Courts and Comparative Law. He began his teaching career at the University of Michigan Law School in 1978. Before that, he practiced law, specializing in civil rights and constitutional litigation. He received a Juris doctor degree from Indiana University School of Law (Bloomington) in 1973.

Professor Burnham's comparative law interests involve Russian law and—within Russian law—Russian criminal law and procedure, constitutional law and the legal profession. In 1992-1993, he served as a consultant to the RF government on legislation introducing jury trials in Russia. During 2000-2001, he served as a foreign law expert for the working group that drafted the 2001 Criminal Procedure Code; he was thereafter invited to attend some of the “monitoring” events held by the working group in various regions of Russia (2002-2006).

Over the years since 1991 he has participated as a teacher, consultant and expert for numerous governmental and private institutions working for legal reform in Russia and the other republics of the former Soviet Union. Professor Burnham has also taught at the law faculties of several Russian, Western European and Asian universities. In 2001, he was the Fulbright Program's Distinguished Chair in Comparative Law at the University of Trento (Italy).

His recent publications are with Peter B. Maggs and Gennady M. Danilenko, *Law and Legal System of the Russian Federation* (Juris Publishing, Huntington, NY, 3rd ed. 2004); a book on US law for foreign lawyers entitled *Introduction to the Law and Legal System of the United States* (Thomson-West, St. Paul, MN, 4th ed. 2006) which has also been published in Russian as: *Pravovaiia sistema Soedinennykh Shtatov Ameriki* (Novaiia Iustitsii, Moscow, 2006) and has also appeared in Ukrainian and Chinese.

Professor Burnham has also been involved in teaching trial advocacy skills to lawyers and law teachers from the countries of the former Soviet Union. His current research interests are the Russian Constitutional Court. His article (with Alexei Trochev), “Russia's War Between the Courts: The Struggle over the Jurisdictional Boundary between the Constitutional Court and Regular Courts”, appears in the Fall 2007 issue of the *American Journal of Comparative Law*. His other comparative work involves research and drafting assistance on the Ukrainian and Georgian criminal procedure codes. In the area of US domestic law, Professor Burnham's interests are

US federal court jurisdiction and suits to protect civil rights. He has published several articles in these areas and has argued cases in the United States Supreme Court involving issues in these fields.

Francis A. Gabor is a Professor of Law at the University of Memphis Cecil C. Humphreys School of Law and a regular visiting professor at the Central European University in Budapest. He has been teaching in the area of public and private international law and comparative and immigration law. Professor Gabor's research interests are focused on current issues of international trade and investments in Central-Eastern Europe. His treatise on Foreign Investment in Hungary was published by Parker School of Foreign and Comparative Law at Columbia University of New York.

His recent publications include, among others: "The Unsettled Status of Economic Refugees from the American and International Legal Perspectives—A Proposal for Recognition Under Existing International Law", 41(2) *Texas International Law Journal* (2006); and "Reflections on NATO's New Mission: Conflict Prevention in the Struggles for Ethnic Self-Determination", 29(2) *Review of Central and East European Law* (2004), 247-256.

Jeffrey Kahn is Assistant Professor of Law at Southern Methodist University, where his teaching and research interests include American constitutional law, Russian law, international human rights law, and legal issues connected with counterterrorism. He received his law degree from the University of Michigan.

Professor Kahn also has a doctorate from Oxford University, where he wrote his dissertation on problems of post-Soviet Russian federalism. His dissertation was subsequently published as *Federalism, Democratization, and the Rule of Law in Russia* (Oxford University Press, Oxford, 2002). Prior to his current appointment, Professor Kahn served as a trial attorney in the Civil Division of the United States Department of Justice. Professor Kahn expresses his gratitude for financial support from the Southern Methodist University Dedman School of Law Summer Research Grant Program.
